M. BIRD, JAMES - ZONING – M-1 - Special use permit issued April 1985 for a gravel pit on approximately 40 acres, located near the Dayton Dredge Tailings, Dayton area (APN 16-151-11)

STAFF OBSERVATIONS: Business license for CB Aggregates & Construction Supply is current and SUP appears to be in use and compliance. No complaints have been received.

N. CARSON TAHOE HOSPITAL - ZONING – C-2 - Special use permit issued March 2005 to construct and operate the proposed Carson-Dayton Hospital on Parcel 2 of PM #155816 and modified June 2005 to expand the proposed Carson-Dayton Hospital to 15 beds and onto an adjoining parcel, being Parcel 3 of PM #155816; on approximately 10.00 total acres; located at 901-1001 Medical Center Drive, Dayton (APN 16-403-30, 16-403-31, 16-403-32, 16-403-33)

STAFF OBSERVATIONS: No business license is in place at this time. Applicant requests that the SUP be extended as construction of the hospital has been delayed due to the economy but they fully intend to build at some time in the future.
